### Explanatory Note

(This does not form part of the Notification, but is intended to indicate its general purport.)

The Additional Central Provident Fund Commissioner, Thiruvanthapuram has requested to the Government to cancel the exemption granted to M/s Fertilisers and Chemicals Travancore Ltd, Udyogamandal Division under Para 27A of the Employees' Provident Fund Scheme, 1952. The Central Board of Trustees has also recommended for the cancellation of exemption granted to the said establishment under the said provisions of the said scheme.
