SUBJECT : SUBMISSION OF ANNUAL PROPERTY RETURN FOR IMMOVABLE PROPERTY FOR THE YEAR ENDING 31.12.2011 - UPLOADING THE SAME IN PUBLIC DOMAIN - REGARDING.

As per 18 (1)(ii) of CCS Conduct Rules 1964, it is mandatory for all Group A officers to submit their annual property return for the year ending 31st December 2011 latest by 31st January 2012.

Vide Ministry of Labour & Employment letter no. C29012/1/2011 – SS I dated 20.09.2011 and C11025/39/2011- SS I dated 01.11.2011, it has been directed to place scanned copies of immovable property return (IPRs) of officers of Group A service on public domain i.e. official website of Employees' Provident Fund Organisation.

Actions have already been initiated to upload the property return of Group A officers in official website www.epfindia.gov.in. However, it has been observed for many officers there is no transaction in the annual property return for the year 2010, thus showing "NIL" or "SAME AS BEFORE" remark.

In this context, it is requested that all Group A officers may be advised to fill all the columns of the property return showing complete details of all the past transactions while submitting the Annual Property Return for the year ending 31.12.2011.
