**Sub:-Resolving J Track issues - Reg.**

Sir,

This is to inform that an analysis of the open J-track issues reported by various offices show that a total of 535 issues are still open, including 243 cases that have been reassigned for actions.

The analysis also reveals that the issues have been reported by 71 offices and 13 of them are having more than 14 cases open.

The Development Team at NDC is rectifying the bugs on priority basis but some of the problems reported by the offices need discussions before resolving them.

It has therefore been decided to resolve the pending issues of J-track by calling the Officer-in-charge of the 13 offices at the first instance at the NDC as per the following plan, so that the issues may be discussed and solutions may be given. The OIC may bring along with him the Nodal Officer/any officer of his choice for the discussions.
