Dear Commissioner,

It has been decided that henceforth the FAÇADE of all EPFO's buildings and the Name Boards have to be uniform. For this purpose, the following decisions have been taken.

**I. COMMON NAME FOR ALL THE OFFICE BUILDINGS:**

- (i) All Office Buildings of EPFO shall be named as "**BHAVISHYANIDHI BHAWAN**".
- (ii) All residential colonies of EPFO be named as "**BHAVISHYANIDHI ENCLAVE**".

**II. COMMON COLOUR FOR ALL THE OFFICE BUILDINGS:**

- (i) All EPFO buildings shall be painted in "Ivory white colour with blue border". The blue colour should correspond to the colour used in EPFO Logo.
- (ii) All new buildings shall be painted in the above manner and as far as existing buildings are concerned the new colour scheme shall be used at the time of painting those buildings next time.

**III. NAME BOARD:**

- (i) All office buildings should have a stand alone sign Board preferably on top of the buildings mentioning "**BHAVISHYANIDHI BHAWAN**".


- (ii) A similar Board shall be placed at the prominent vantage point of the colony also, mentioning Bhavishyanidhi Enclave

Specimen of the above Boards with colour to be used is annexed to this letter. The size of the font and style used in the sample (which is A4) "Arial 48" in English and for Hindi "Mangal 54". The font may be enlarged proportionately to the size of the Board fixed.

- (iii) Name Board in Blue and White with EPFO Logo and address shall be placed in front of Office Buildings and Office colonies. The specimen of the same is also enclosed for guidance.

Action may be taken to implement all the above instructions at the earliest and reported to Head Office for information.
