Sub: Generation of EID for the EPF Employee Pensioners through the HR Software - reg.

Sir/Madam,

As the HR Software launched for EPFO employees is presently handling the details of the currently employed employees, it has been decided by the Competent Authority to provide a facility for the Pensioners also and handling of the post retirement functions for them. A note in this regard has been received from the ACC (HQ) HRM.

- 2. To facilitate this, there is a need to issue the EID for our retired employees also. The revised format for the generation of the EID for the retired employees is attached and is also available in the login of the Users under the Help Link.
- 3. All Regional Offices/Head Office/NATRSS/ZTIs are requested to kindly prepare a list of pensioners drawing pension from their respective office. The entire list with the following details should be mailed to the RPFC, NDC in the following format:
- Sl. No., Name of the Employee, Designation at the time or retirement/death, date of death (if applicable only) {in xls only}
- 4. EID generation request should be sent in the revised format to the RPFC, NDC for such employees who do not have the EID generated. The search facility in the HR Software facilitates checking whether an employee has got EID or not. As in other cases the EID generation request for the EPF Pensioners/Deceased Employees where Pension is being disbursed to family, may be sent to the following e-mail id:

5. In case of the employees who have since deceased and the family is drawing pension also the EID will be generated in the name of employee only and the Pension Function will link them to the beneficiaries.

6. At present, the scanned photo, signature and the physical signature of the pensioner are not required and the EID request may be certified by the APFC looking after the Pension cases.
