Madam/Sir,

Instructions were issued from time to time *vide* above referred circulars with a view to ensure timely completion of online APAR for the year 2016-17 in respect of officers in the cadres of Addl. CPFC, RPFC and APFC. All the PAR Custodians were directed vide circular dated 28.11.2017 to ensure completion of APARs as per the deadline indicated therein and were also asked to use the functionality of <u>'Force Forward'</u> in case an APAR is pending at any level beyond the deadline.

- 2. However, as per the system generated report, there are many officers who have not yet filed/assessed the APAR through SPARROW application software. SPARROW dashboard report showing pending APARs at various levels in respect of each erstwhile Regional Office is enclosed for ready reference.
- 3. NIC had informed about closure of APAR for the year 2016-17 at the midnight of 31.12.2017 which means closure of all the APARs pending at any level at the midnight of 31.12.2017. However, they have been requested to keep the closure activity on hold for some time.
- 4. Therefore, all the officers may be directed to <u>complete APAR-related activity</u> <u>pending in their SPARROW login/account, immediately or latest by 05.01.2018</u>. Failure to file self-resume by said date may entail forfeiture of right to submit the same. Failure of Reporting/Reviewing Authorities to assess APARs by said date would be viewed very seriously.
