**Subject : Registration of Users on LIMBS portal – reg.**

Sir,

Please find enclosed herewith a copy of notification dated 08.02.2016 of Department of Legal Affairs, Ministry of Law and Justice, Govt. of India regarding launch of Legal Information Management and Briefing System (LIMBS ) portal, which is self explanatory.

2. Ministry of Labour has requested that atleast one user in every office of the organisation associated with the Ministry may be registered on LIMBS portal.

3. Legal Information Management and Briefing System (LIMBS) portal has been launched by Department of Legal Affairs, Ministry of Law and Justice so as to monitor conduct of cases on behalf of Union of India and Organisations, Departments etc under the administrative control of Central Government through web based application. LIMBS is a web based platform which provides common access portal to all users having varying needs and a web based tool for comprehensive, regulatory and pro-active monitoring of court cases. The link <http://www.limbs.gov.in> contains FAQs and steps to register for new user.

4. The existing "Nodal Officer for Legal Dashboard" shall be the nodal officer in each office for LIMBS. In offices where such officers are not available ( Viz., PUDNASS, ZTI, Zonal Office etc.), an officer not below the rank of APFC or equivalent may be nominated for this purpose. After successful registration of Nodal Officers on LIMBS Portal (<http://www.limbs.gov.in>), details of all cases (including existing cases) are required to be entered in the LIMBS portal in addition to parallel data entry on Legal Dash Board until further orders. Under LIMBS, all legal cases including prosecution cases under Section 14 of the Act should be dealt with and monitored. Details of all new cases should be entered in LIMBS portal mandatorily with effect from 1<sup>st</sup> July, 2017.

5. Cases pertaining to Section 7A, 7B, 7C, 7Q , 14 B etc. of the Act shall continue to be conducted and monitored through e-court mechanism which need not be incorporated in to this system.

This may be given Top Priority.


No.A-60011/14/2014-Admn.IV(LA) : The Department of Legal Affairs has launched Legal Information Management and Briefing System (LIMBS) so as to monitor conduct of cases on behalf of the Union of India and Organizations, Departments etc. under the administrative control of Central Government through web based application.

2. LIMBS is a web-based platform which provides a common access portal to all users having varying needs and cutting across administration pyramids i.e. access is available right from the file dealing hand to the top management. LIMBS has user friendly data entry screen for capturing the details of court cases. Progress of court cases can be entered. Various MIS reports help to monitor these cases. E-document vault allows user to enter the important judgment. SMS alerts are used to sensitize the users over important issues.

3. The LIMBS application will host huge data, involve various stakeholders, Nodal Authorities to take data driven decisions, know the date of hearing in advance and may enable the authorities to prepare their response in advance. For the purpose, a LIMBS Steering Committee has been constituted as follows :-
