Subject: - SUPPLY OF INFORMATION UNDER RIGHT TO INFORMATION ACT, 2005.

Whereas Shri Sameer Vaidya, R/o 769/770, Suyash Apartments, Sadashiv Peth, Pune, Pin: 411030 has made a request in writing his on line RTI application vide Registration No.EPFOG/R/2017/52295 dated 18.05.2017 under RTI Act. 2005 for obtaining information under Section 6(1) of RTI Act, 2005.

2. Whereas the undersigned having been appointed as Central Public Information Officer under Section 5(1) of the said Act is required to consider and provide the information within 30 days of the receipt of the request.

3. And whereas Section 5(4) of the Act provides the Central Public Information Officer may seek the assistance of any other officer as he/she considers it necessary for the proper discharge of his duties. Sub-Section (5) further provides that any officer whose assistance has been sought shall render all assistance to the Central Public Information Officer. Once the complaint is referred "for the purposes of any contravention of the provisions of the Act, such other officer shall be treated as Central Public Information Officer" and may be liable for penalties under Section 20 of the said Act. Further in the event of violation of provisions/ non-furnishing of documents/information such an officer is liable for penalties under Section 20(1) of the Act @Rs. 250/- for each day of delay which may extend up to Rs. 25000/-.

4. And whereas under Section 6(3) of Right to Information Act it has been provided that

"Where an application is made to a public authority requesting for an information:-

- (i) Which is held by another public authority; or
- (ii) The subject matter of which is more closely connected with the functions of another public authority.

5. The public authority, to which such application is made, shall transfer the application or such part of it as may be appropriate to that other public authority and inform the applicant immediately about such transfer."

6. Whereas on scrutiny of the application I find that the Information sought by the applicant on the following point:

"Kindly provide the details of withdrawal applications received/ sanctioned/ rejected/amount sanctioned under Para 68 of the EPF Scheme in the period from Feb 2016 to January 2017 and from feb 2017 to April 2017."

7. On line RTI application Registration No.EPFOG/R/2017/52295 dated 18.05.2017 **(copy enclosed)** is closely related to and held by CPIO/Regional Offices. The undersigned invokes the provisions of section 5(4) of the said Act and transfer the application to furnish the information/documents sought by the applicant under the Act within 7 days of the receipt of this communication directly to the applicant under intimation to the undersigned. An amount of Rs. 10/-(Ten only) has been paid by the applicant being the application fee.

8. This may please be treated as most urgent.
