





The induction of PF pension scheme to all PF subscribers in 1995 was warmly welcomed. Unfortunately, the scheme was not to the up-lift of PF pensioners, but to heap money in the PF account by pension fund, non- pension fund, unclimbed as on 31.03.2016 reached Rs. 10,43,581.67 Crores plus Rs.40,865 Crores (as unclimbed) and to create 2 types of people - have and have not contains PF pensioners - drawing pension about Rs. 2000/- or below- the others service pensioners and PF pensioners drawing pension based on the entire salary-lucrative service pension got revised 2 times in a year along with another on salary revision and even PF employers itself drawing other than PF Pension, seems no favorable hand expected among the dealers - CPFO.

Admitted to hold non -pension subscriptions to PF and Vol. PF contribution to Govt. undertakings smells unholy nexus in between employer and bank, especially new generation Banks. Not disburse fund on retirement, even lagged to 10 years with the intended money were in bank with lower rates. Computing lower rates of interest then fixed by PF., calculation are not correct. 2.75 years taken to disburse my PF money after retirement, as piecemeal and till date not settled as I was retired on 19.07.2013 from Kerala Agro Industries Corporation Ltd. having Head Office at Kissan Jyothi, Fort, Thiruvananthapuram -23 and my predecessors account were settled after 10 years.

Again it was learned that some establishments were subscribing pension fund on the entire salary and got pension in the entire basis and seen that the CPFO was not published or promoted and created 2 type citizen, which is a challenge to live equality seems against the law of Constitution of India. There by PF pension scheme seems the most poor pension scheme in the world, ordinary pension now attained only about Rs. 2000/- or below

As on 31.03.2016 the CPF account, there an amount of R. 448252/- crores and total pension paid as 8263. 04 crores i.e. 448252 crores interest at 8.65% gives 38773.798/8263.04 gives 4.6924374. i.e. 4.69 times of pension can be payable as on 31.03.2016 since this is a long time amount chargeable @ 10/12 %. Interest still takes 5.42/6.5 times higher of present pension.

Again there were a growth recorded in the year 2013-2014, 2014-2015, 2015-2016 as 16.91, 18.41, 19.25 % which means the due share as pension was not disbursed to the pensioners on the fag end of the life .

I had urged the complete details of the beginning of 4/1995,4/2000,4/2005,4/2010,4/2015, 4/2016 was not supplied in complete. Could have furnished accordingly.

Under the circumstances kindly inform under RTI 2005, the following.

1. Any revision in PF pension was occurred in the tenure of PF pension and any revision was under consideration- the pension section of CPFO informed that the question was not clear -i. e a person drawing a pension of Rs. 1500/- on the retirement, any enhance was occurred on Rs.1500/- and liable for enhance in the next future. .
2. The authority taken of Rs.6500/- as base for pension fund recovery and mandate taken to fix R.6500/- leaving behind the entire salary.
3. Total no. of pensioners drawing pension based on the entire salary and total pension amount belongs in the group and maximum pension paid per person.
4. The date on which the higher pension drawing (based on the entire salary) and reason for not insisted on others.
