With reference to the above cited subject and transfer policy under reference, it has been decided to prepone the Annual General Transfer, 2024 Commissioners' cadre in light of the upcoming Lok Sabha elections.

10 <sup>th</sup> January, 2024	CTC to prepare the panel and submit recommendations to Competent Authority.
15 <sup>th</sup> January, 2024	Order for AGT to be issued.
15 <sup>th</sup> to 18 <sup>th</sup> January, 2024	Online grievance representation by those aggrieved by order of AGT.
By 25 <sup>th</sup> January, 2024	Comments of the CTC on grievance representations to be forwarded to the Competent Authority.
By 30 <sup>th</sup> of January, 2024	Disposal of grievance representation by Competent Authority by passing a speaking order.
31 <sup>st</sup> of January, 2024	Date of the effect of the order of AGT i.e. officer to join new posting as per AGT order.


