- · Updation of Circulars/Guidelines/manuals

As part of the Commission's campaign on housekeeping activities and record management, EPFO could remove 96000 old unused files and closed more than 2700 e-files, which shows EPFO's commitment to maintaining a well orgainsed system. The exercise also generated revenue of nearly Rs 19 Lakhs for which EPFO was amongst the Top 5

Organisations in the country. Furthermore, 02 initiatives of EPFO, namely E-inspection and Principal Employer (PE) Portal were also chosen by the CVC as one of the Best Practices amongst the Organisations during the VAW 2022. This year, too, the CVC has shortlisted the SOP on Inspection of Establishments as one of the Best Practices as part of VAW 2023.
