Office Order

Subject: Rationalisation of Regional Office, Noida & Opening of 1 New Regional Office

The competent authority has accorded approval for Rationalisation of Big Regional offices having membership more than 7.5 Lakhs as per the criteria mentioned in para 8 and para 9 of the Agenda Item No 10 placed before 103rd EC Meeting dated 19.10.2022. As per the approved basic principles/norms, re-distribution of the workload would be done among the existing Regional offices sharing common jurisdiction or to other Regional Offices with geographically contiguous jurisdiction or by carving out a new Regional Office from the existing Offices for ensuring equitable and manageable distribution of workload.

2. As per above approval, the Regional Office Noida having around 9.57 lakh contributory membership being more than 7.5 lakhs is to be rationalised. This is being done by opening of 1 new Regional Offices and re-organising the workload in both Regional Offices with respective jurisdiction as below:

- 3. The revised PIN Code wise jurisdiction of the Regional Offices Noida & Gr. Noida is enclosed as **Annexure I, II** respectively.
- 4. The re-distribution of Officers & employees between the 2 Regional Offices is to be done in proportion to the above workload in such manner that total sanctioned strength remains same for now. The bifurcation of sanctioned strength of officers/staff will be as per Annexure-III.
- 5. Addl. CPFC Kanpur will re-distribute the staff taking into account following principles:-
 - 5.1 The officers and staff in-position shall be bifurcated in the same proportion as bifurcation of sanctioned strength.
 - 5.2 Options for specific offices will be called for from the staff (Gr B & Gr C).
 - 5.3 In case, more options are received for a particular office, then staff with the longest tenure in the current office will get preference.

- 5.4 In case inadequate options are received for an office, then staff with longest tenure amongst the non-optees shall be distributed.
- 5.5 ZO will also divide the budget for the new office so that they can function effectively.
- 6. Office space for New Regional Office be hired immediately as per PFD norms at the earliest to make the new Office Functional. In addition adequate furniture, equipment, IT infrastructure and other facilities may be ensured as per norms and requirement. Essentially, MPLS connectivity shall be fast tracked for the efficient functioning of the office. The balance sheet etc will be made separate for FY 2024-25 onwards. For the future purposes steps may be taken to acquire office space (Land/Building) for making the new office self sufficient.
- 7. Till bifurcation of Accounts by IS Division as per reorganization, the claim settlement and related work will be done from current offices PDB i.e. RO Noida. The Zonal Office shall ensure the completion of preparatory activities at the earliest for the formal inauguration of the office.
- 8. This order shall be effective from the date of formal inauguration of the office.
