With reference to the Detailed Notice No. Exam.4(1)2019/Assistant Published on 17.05.2019 , addendum dated 28.05.2019, corrigendum dated 11/06/2019, and addendum dated 17/06/2019; published on the EPFO Website www.epfindia.gov.in, for recruitment to the post of Assistants (Pay Level-7) in the Employees' Provident Fund Organisation, **it is hereby informed to all male Economically Weaker Section candidates (EWS)** who have applied for the post that EWS category was inadvertently included in the category of candidates who are required to only Rs. 250.

2. **Male Economically Weaker Section candidates (EWS)** who have applied for the post by paying a fee of Rs. 250 are hereby informed that they are required to pay additional fee of Rs.250 on or before 10th July, 2019 (24:00 hrs) in order to be eligible for appearing in the examination. 3. Call letter for Phase-I examinations will not be issued to those male EWS candidates who fail to deposit additional fee of Rs. 250/-. Those who do not want to appear in the examination by paying additional fee may intimate the same by giving full details including a scanned copy of his application to rpfc.exam@epfindia.gov.in for refunding the fee of Rs. 250 paid by him.
