
The Government of India, Ministry of Labour and Employment has issued notification on enhancement of wage ceiling from existing Rs. 6,500/- to Rs. 15,000/- and the same has already been uploaded to the web site by this Office circular dated 28.08.2014 (placed at Sl. No. 388 in the circular segment of the official website for the year, 2014-15).

2. The above notification has to be brought to the notice of all the stake holders and should be given wide publicity to bridge the gaps in the coverage. The following actions need to be taken by the field offices urgently:

- a) A press meet may be called to brief the press about the notification on enhancement of wage ceiling.
- b) Press releases may be made by all the Regional Offices through electronic and print media in local language.
- c) The copy of the notification shall be sent to all the employers of the establishments covered under their jurisdiction in e-mail under copy to ACC – I (Compliance), Head Office.
- d) Field Offices will conduct meeting with the employers to brief them about the notification and send a report to Head Office.

- e) Field Offices will arrange for meetings with the representatives of the Trade Unions and various Employees Unions to enlighten them about the notification. A report in this regards may be send to Head Office.
  - f) Chairman , Regional Committee may be requested to hold urgent meeting of Regional Committees to inform all the stake-holders so that the message on this notification can be passed on to all the employers and workers working in various establishments.
- 3.** The Additional Central PF Commissioners In-Charge of Zones will also conduct meetings with stake-holders – Employers’ Association, Chamber of Commerce, Central Trade Unions etc. and brief them about the notification for their cooperation to bridge the coverage gaps.
