As you are aware that for strengthening of administration and to ensure probity among Government Servants, a periodical review under 56 (j)/ Rule 48 of CCS (Pension) Rules, 1972 has been mandated. Accordingly, all concerned have been reminded time and again that a review under 56(j) and Rule 48 of CCS (Pension) Rules, 1972 may also be undertaken in respect of your organizations. I had also stressed the need for immediate review during Senior Officers' meeting.

2. In the recent meeting taken by Cabinet Secretary on 12.06.2017, it was again emphasized for timely completion of such exercise. Further, the Cabinet Secretary has also directed that the updated information be furnished under 56j on the probity portal by the 15th of every month by the respective ministries pertaining to the progress made during the preceding month.

3. I would, therefore, like to urge upon you to take necessary action and complete exercise of review under 56j within 10 days, if not already done. An action taken report may also be sent.
