Sub: Internal Procedure for processing coverage applications under section 1(4) of the EPF & MP Act, 1952- regarding.

Sir

Please refer to this office circular No. C-IV/Vol.Cov/Misc./DL/NZ/35929-1129 dated 13-02-2009 on the above mentioned subject wherein the procedure for processing coverage applications under section 1(4) of the Act was explained enclosing a Performa required to be submitted by the Zonal Addl. CPFCs.

On a further review it has been found that certain changes are needed in the Performa required to be submitted by the Zonal Addl. CPFCs.

Accordingly, a revised Performa is enclosed (overleaf), incorporating certain additional information required to be submitted/ collected from the different field offices. All Zonal Addl. CPFCs are requested to forward recommendations for coverage u/s 1(4) for approval of the Central P.F. Commissioner in the revised Performa. It is reiterated that the original application or any other documents except the Performa and the month wise payment position of the establishment should not be sent to Head Office.

The other procedure of Zonal Addl. CPFCs for making arrangements for notification of such establishment u/s 1(4) directly, remains unchanged. After making notifications in the official Gazette, a copy of the notification may be sent to Head Office.
