Madam /Sir.

Please refer to Head Office letter dated 17.03.2017 (website Sl.No.690) regarding the conduct of the Direct Recruit APFC Probationary Examination at PDUNASS, New Delhi from 03.04.2017 to 07.04.2017.

- As per the EPF (Probationers') Examination Scheme, as amended from time to time, General Category candidates have to obtain minimum 45% marks in each paper and SC/ST Category candidates have to obtain minimum 40% marks in each paper to pass the Probationary Examination. Thus, candidates who are absent in even one paper or those who do not get the minimum qualifying marks in even one paper are considered as 'FAIL' in the examination and will have to appear for the same again. However candidates who have failed to qualify in the examination but have secured 50% and above in any one of the papers will be granted exemption in that paper and will not have to appear in that paper in the next examination.
- 3. The result of the examination has been prepared as per the provisions of the aforesaid Scheme and is enclosed for information of all and is subject to outcome of changes due to re-totalling etc. Those candidates who have failed in the examination and are required to appear for one or more papers may be directed to appear in the next APFC Probationary Examination.
- As per the aforesaid Examination Scheme, facility is provided for candidates who desire re-totalling of their marks and verification of the fact that all the answer written by them have been duly assessed by the examiner and there is no mistake in the totaling of marks. Provision for re-totalling of marks is available on payment of Rs. 100/- per paper. The application for re-totalling should be submitted by the candidate to Head Office through his/her Regional Office for undertaking the re-totalling and verification. Such application is to be

submitted within <u>two weeks</u> from the date of communication of the result. There is no provision for revaluation of the answer paper. The application for re-totalling may be forwarded in the format given under:-
