#### **OFFICE MEMORANDUM**

Sub: Final Seniority List of Private Secretary in the scale of Pay Band-2 (Rs. 9300-34800) Plus Grade Pay of Rs. 4800/- (Level 8 in the Pay Matrix) as on 01.04.2017-regarding.

A Draft Seniority List of Private Secretary in the scale of Pay Band-2 (Rs. 9300-34800) Plus Grade Pay of Rs. 4800/- (Level 8 in the Pay Matrix) in Employees Provident Fund Organization as on 01.04.2017 was circulated vide this office letter of even number dated 08.03.2017.

- 2. The discrepancies/objections with regard to name, date of birth, category, qualification, inclusion of name etc. received in Head Office have been considered and necessary amendments have been carried out in the Seniority List. In certain cases where objections were related to seniority position, point wise replies are being issued to the officials with the approval of the Competent Authority.
- 3. This Seniority List is prepared by considering the following:-
  - (i) Seniority in respect of S.No. 1 to 10 who were holding the post of Personal Assistant prior to implementation of judgment passed by the Hon'ble CATs in OA No. 2234/01 in the matter Vinod Grover & Others Vs UOI, OA No. 237/04 in the matter of B.T. Krishna Rao & Others Vs. UOI and Others and OA No. 125/2007 in the matter of V. Vijaya Vs UOI & Others and whose seniority already finalized vide order dated 20.11.2002 as deemed to be appointed as Private Secretary w.e.f. 14.07.1997.
  - (ii) The seniority of officials at S.No. 11 onwards has been fixed with reference to date of appointment as Steno Grade –III as available on record since the promotion have been preponed to 14.07.1997 and all of the officials were not holding the post of Personal Assistant. Hence, the date of appointment as Stenographer Grade-III has been taken as date of appointment in the feeder grade.
  - (iii)The officials whose date of promotion is subsequent to date of 14.07.1997 their seniority has been fixed as per date of regular promotion as Private Secretary.

- (iv) It is further clarified that the promotion to the post of APFC were affected on the basis of Final Seniority List of Private Secretary as on 31.07.2004 issued vide letter dated 12.05.2005. The said seniority list was issued prior to implementation of CAT's judgments as mentioned in para 3(i) above and by applying the principle of reservation on the regional basis. However, due to preponement of seniority w.e.f. 14.07.1997 and considering the date of appointment as Stenographer Grade-III, the seniority position has been changed and the officials who were promoted earlier as APFC placed below the officials holding the post of Private Secretary.
- (v) Since the Seniority List of Private Secretary has been prepared after a long period of time, the names of the Private Secretary who had already left the cadre by way of retirement, superannuation, promotion etc. have also been included in the Final Seniority List in order to keep their seniority position for the purpose of information and record.
- 4. The Final Seniority list of Private Secretary is accordingly circulated herewith for information of all concerned.
- 5. As there are some pending cases like WP © 493/2010 in the matter of Shri Ashok Bhatt and OA No. 4281/2011 and the matter of Shri Harish Makhija (clubbed with the case of WP No. 3996/2014) before the Hon'ble High Court of Delhi and other matter pending before various benches of CAT, this seniority list would be subject to the outcome of these cases.
- 6. It is further clarified that consequent to the issue of final seniority list as on 01.04.2017, no further representation or objections will be considered in this regard.




