**Subject: Timely action for making promotion to the post of Section Supervisor and intimation of vacancies for holding examination for Departmental Examination Quota –reg.**

Madam/Sir,

Kind attention is invited to Headquarters Office instructions regarding timely conduct of DPCs to fill up the vacant posts in various cadres for whom the Zonal Addl. CPFC and erstwhile RPFC-I are the Appointing authorities as well Cadre controlling authority.

2. In this regard, it is further to inform that revised Recruitment Rules for the post of Section Supervisors have since been notified in the Gazette Notification (Extraordinary Part-III-Section-4) No. 459 dated 06.12.2017. Hence, it is incumbent upon all the Zonal Addl. CPFC and erstwhile RPFC-I to initiate preparatory activities immediately to convene the DPCs to fill up the vacancies against the Seniority Quota for the year 2016-17. The activities may be so planned that the DPCs are completed within next 10 days time.

3. As per the Recruitment Rules, 33 2/3% of the vacancies have to be filled by Examination Quota. For the Examination Quota action has been initiated by the Head Office to notify the vacancies for conducting examination as per the revised notified Scheme for the post of Section Supervisor. The vacancies reported to Head Office as on 31.03.2017 has been complied and may be seen in Annexure-I. However, it is advised that the state wise vacancies position for post of Section Supervisor as 31.03.2017 may be confirmed immediately that these vacancies are as per the vacancy roster and the break-up of the vacancies are as as per the reservation roster. A confirmation report may be sent to HRM Division within three days and in any case by 13<sup>th</sup> December, 2017 by email to [rc1.hrm@epfindia.gov.in](mailto:rc1.hrm@epfindia.gov.in) positively.

4. In this regard, attention is also drawn to Headquarters Circular No., HRM-5/2(13)2013/SS/Seniority/Vol.I/1127 dated 13.04.2017 regarding implementation of the Order of Hon'ble CAT, Ahmedabad Bench in O.A. No. 263/2010. Therefore, while confirming the vacancy position it is to be ensured that the said instructions have been followed and actions have completed to revert the officials who were working on regular/ad-hoc basis appointed in excess of the vacancies from the erstwhile panel. The Zonal Addl. CPFC shall also intimate to Headquarters whether there are any other matter pending before Hon'ble CAT and whether any interim stay order has been passed by the CAT or otherwise.

5. This issues with the approval of Central PF Commissioner.
