- 3. In so far as the Sub-divided ROs the distribution as per the requirement among the divided offices may be done by the Zonal ACC duly ensuring that the sum of all such distributed sanctions does not exceed the sanction given to the erstwhile RO.
- 4. Each Office shall follow GFR provisions the delegation of Financial Powers and CVC instructions for selecting the vendor for hiring the services through tendering process.
- 5. It should however be ensure that the output of the manpower so engaged is monitored timely and regularly and payment is made only after ensuring the minimum required output from each person as per the norms for data entry work.
