Subject: Implementation of order dated 13-3-2015 of Hon'ble CAT, Ahmedabad Bench in OA no. 263/2010 -Promotion to the post of Section Supervisor under Examination Quota

Sir,

It is brought to your notice that based on the Employees' Provident Fund Departmental Promotion Examination Scheme, 2002 departmental examination for promotion to the post of Section Supervisor was conducted on 18.12.2007. The final select list of the candidates was issued on 9.1.2009 on the basis of the results.

- 2. In 2010,15 persons who could not appear in the above-mentioned examination approached the Central Administrative Tribunal, Ahmedabad bench by way of an Original Application being O.A. No. 263/2010 inter alia praying for quashing the select list dated 09.01.2009. The Ld. Central Administrative Tribunal vide order dated 09.05.2012 was pleased to allow the Original Application. However, it was ordered that the regular promotions already made were not to be disturbed. Thereafter vide Circular dated 20.9.2012, it was informed to all field offices that department has decided to accept and implement the above CAT order.
- 3. But on 11.01.2013, some officials who had not joined as parties to O.A. No. 263/2010 approached the Hon'ble High Court of Gujarat by way of a Special Civil Application No. 13224/2014. This Hon'ble Court was pleased to set aside the order dated 09.05.2012 passed by the Central Administrative Tribunal, Ahmedabad bench and remanded the matter to the Tribunal with directions to hear the parties also.
- 4. Thereafter, the Ld. Tribunal, Ahmedabad Bench allowed the O.A. No. 263/2010 vide a reasoned order dated 13.3.2015. The Operative portion of the judgement reads as under:

- "26.In the result, issue Nos. (i), (ii), (iii) and (v) are decided in favour of the applicants. Issue No. (iv) is decided in favour of the Respondents.
- 27. Thus, the O.A. is partly allowed as above. The respondents are directed to operate the impugned Select List dated 09.01.2009 up to the extent of five reported vacancies and for filling up the Examination Quota, if any, in the 49 vacancies that have been additionally sanctioned in the Head Office letter dated 26.12.2008 annexed to the additional reply filed by the counsel for the respondents on 19.01.2012 as these vacancies are available before the finalisation of Select list of 09.01.2009."
- 5. The order dated 13.03.2015 passed by the Hon'ble Central Administrative Tribunal Ahmedabad Bench was challenged by certain officials vide various Special Leave Applications being Special Civil Application Nos. 5231 of 2015 and 6188 of 2015 respectively. The Hon'ble High Court of Gujarat vide order dated 08.10.2015 upheld the judgement dated 13.03.2015 passed by the Hon'ble Central Administrative Tribunal, Ahmadabad Bench. The Operative portion of the judgement reads as follows:
  - "7.10. At this stage, it is required to be noted that as observed hereinabove, as and when departmental examinations are conducted, there shall be different departmental examinations and examiners also shall be different and therefore, unequal shall be treated equally. As observed hereinabove, so far as 33 1/3rd % quota is concerned, merit is the only criteria. Under the circumstances also, merit list prepared on the basis of earlier departmental examinations cannot be permitted tobe operated in perpetuity and/or till it is exhausted and the same shall be restricted to only those notified declared vacancies at the time of taking departmental examinations and the same cannot be permitted tobe operated for subsequent vacant notified / declared vacancies in the particular region. Under the circumstances, the learned tribunal has not committed any error in allowing the O.A. and in granting the reliefs restricting the merit list / select list dated 9/1/2009 for the declared / notified vacancies. At this stage, it is required to be noted that even the learned tribunal has directed to operate the said merit list even with respect to the posts which were declared subsequent to conducting of the departmental examination, but prior to preparation of the merit list / select list dated 9/1/2009, however, the same is not under challenge and therefore, we are not observing anything with respect to the same."
- 6. The department also filed a Special Civil Application being Special Civil Application No. 2534 of 2016 against the order dated 13.03.2015 passed by the Hon'ble Central Administrative Tribunal, Ahmedabad Bench and on 11.7.2016, the Hon'ble High Court of Gujarat pronounced the judgment. The operative portion of the judgement is as follows:

- " 4. In view of the above facts and circumstances, now when the very impugned judgment and award impugned in the present petition has been confirmed by the Division Bench of this Court vide order dated 08/10/2015 in Special Civil Application No.5231/2015 and Special Civil ApplicationNo.6188/2015, the present Special Civil Application will also have the same fate. For the reasons stated in the judgment and order passed by the Division Bench of this Court dated 08/10/2015 in Special Civil Application No.5231/2015 and Special Civil Application No.6188/2015, we dismiss the present petition also. Notice discharged."
- 7. Since the Hon'ble High Court of Gujarat had not considered the grounds submitted before the Court, the above judgment was challenged by the department as well as certain officials of Gujarat region in the Hon'ble Supreme Court vide SLP(Civil) CC no.4928-4930/2017 and 4579/2017. However, the Hon'ble Supreme Court vide its order dated 6.3.2017 has dismissed the above SLPs observing that it did not find any ground to interfere with the impugned order.
- 8. Considering the facts of the case and that all the legal recourse/remedy available for the Department have exhausted,RPFC Gujarat has been directed to implement the order dated 13-3-2015 passed by the CAT,Ahmedabad Bench vide letter dated 15-3-2017. It has been further decided that in case of all the regions other than Gujarat, the candidates who were declared qualified in the above examination or the examinations conducted for Section supervisor earlier and have been promoted under examination quota in SS cadre in excess of the vacancies as shown Annexure I and the posts created in SS cadre vide HO letter dated 26.12.2008(Annexure-II) may be issued show cause notice as to why they should not be reverted to their original cadre. However, the officials among them who can be promoted to the post of SS under Seniority quota in view of the implementation of cadre restructuring report in the normal course may be promoted immediately by conducting DPCs and details of remaining officials who are left out and reverted may be sent to Head Office through concerned Zonal Office by 30.4.2017 positively.
