- He will not claim seniority in the next grade by virtue of this financial up gradation.
- His name will continue to be in the seniority list of the regular post in the cadre and
- All conditions stated in Annexure-I of ACP/MACP Scheme of DOPT vide OM No. 35034(1)97/Estt. (D) dated 09.08.1999 and OM No. 35034/3/2008-Estt. (D) dated 19.05.2009 shall be applicable to the financial upgradation.
