



As you are aware, the preparations for the celebration of 3<sup>rd</sup> International Day of Yoga on 21<sup>st</sup> June, 2017 are underway. The main programme would be the Mass Yoga Demonstrations from 7 AM to 8 AM by following the Common Yoga Protocol (CYP) at the State, District, Block and Panchayat levels. Other events could include Yoga Fests, seminars, workshops, musical and cultural programme based on Yoga.

The celebration of International Day of Yoga would involve a very elaborate training programme on Common Yoga Protocol for Mass Yoga performance as well as discourses, lectures and talks by eminent Yoga experts. Support of various reputed and eminent Yoga institutions may be taken for providing training to the trainers and other expert advice in celebration of International Day of Yoga, 2017.

I would be grateful if you could issue necessary instructions to all officers of your Ministry/Department and attached & subordinate offices located in different parts of the country to prepare a detailed action plan for celebrating the International Day of Yoga, 2017. I would also request you to forward your Plan of Action along with suggestions if any to the Ministry by 31<sup>st</sup> March, 2017.
