Sub: Supplementary Norms for Mobile Devices covering the requirement of registration of Digital Life Certificate (DLC) of Jeevan Praman for Pensioners through "UMANG" – Regarding

Sir,

Reference is invited to Pension Division letter referred above on the above subject.

2. The Norms that were approved and communicated earlier cover the basic requirement of field offices, Head Office, Zones, PDNASS / ZTIs, Zonal Vigilance Offices and Zonal Audit Setups.

3. Furthermore, to cater to the requirement of registration of Digital Life Certificate (DLC) of Jeevan Praman for Pensioners through "UMANG" (Mobile Application), the new additional requirement of mobile devices for the field offices has been decided and the specification of the mobile device is enclosed herewith to capture the required information.

4. The procurement should be made strictly in accordance with the provisions of GFR 2017 and CVC guidelines / instructions issued from time to time.

All existing bio metric devices / IRIS Scanners may be upgraded to the latest software recommended by UIDAI and hereby required to install Registered Device services (Software) and get your device activated/registered through your vendors. For information, please visit <https://jeevanpramaan.gov.in>.
2. The Jeevan Pramaan client application 3.0 (Android) will work on KitKat and above version. Further, the connectivity with the recommended finger print device (as recommended by UIDAI / UMANG) must be tested before placing the purchase order.
