## Sir/Madam,

Please refer to this office letter of even no. 1275 dated 05.04.2017 vide which Training Calendar for the year 2017-2018 was circulated for information of all concerned.

- 2. In this regard, you are requested to circulate the same amongst all **Group 'A'** officers of your office with the advise to send in their preferences (**upto 5 preferences**) for attending the training programmes in the year 2017-2018. The officers need to keep the following while submitting their respective preferences:
- (i) The officer is required to mention upto five training programmes in preferential order out of the training programmes mentioned in the Training Calendar 2017-2018. The designation wise eligibility for various training programmes is attached herewith.
- (ii) The officer should not have attended the same Training Programme during last five years i.e. from 2012-2013 to 2016 -2017.
- (iii) The officer's date of superannuation should be after 31.03.2018.
- (iv) Preferences for the Induction Training Programme for Newly Promoted APFCs may be submitted by those APFCs only who are promoted recently vide H.O. order no. HRM-II/P-141(9)17/APFC/Part –III/739 dated 12.04.2017 except those who were already working as APFCs.
- (v) For Refresher Courses, only the APFCs of 2016 Batch are eligible to submit their preferences.

3. After receipt of preferences from the officers, PDUNASS will issue final list of training-wise nominations. If any officer fails to send preference for any training, his/her name will be included in the Training Programmes by PDUNASS as deems fit.
