

I am the citizen of India and a pensioner under EPS 1995.. I request you to furnish the following information within 48 hours as the matter concerns with "life and liberty of a pensioner, as per the Orders of the CIC, New Delhi.

- Certified copy of the circular/advisory letter issued by EPFO Head Office to your various Field Offices at Palakkad, Kollam, Kozhikode, Kottaiyam, Trivandrumand any other EPFO Office in the State of Kerala (after the Orders of the Hon'ble Supreme Court dated 30.3.2016 and dated 12.7.2016 dismissing the SLPs in the matters of the Exempted Establishments viz. FACT, Hindustan News Prints, Kerala State Handloom Dev. Corpn., Kerala Agro Machinery Corpn., ITI, Instrumentation Ltd., IOC and AAI etc.) advised them to call for 8.33% of the employer's contribution of the higher salary exceeded the statutory wage ceiling of Rs.5000/-, Rs.6500/- from time to time with up to date interest as declared under EPF Scheme 1952 and to the Pension Fund and to give the benefit of Pension on higher Salary and the Joint option of the employer and employees.
- Certified copy of the Agenda submitted by the EPFO, HO to the PEIC and CBT meetings after the dismissal of the above SLPs and the recommendations of the PEIC and CBT for implementing the revised pension for the members of the Exempted Establishments as per the Orders of the Hon'ble Division Bench of the Kerala High court.
- 3 Certified copy of the proposal, after the dismissal of the SLPs, in respect of the Exempted Establishments in the State of Kerala sent by the EPFO, HO to the MOL&E and the approval of the Ministry of MOL&E received by the EPFO for implementing the revised pension benefits, as per the Orders of the Kerala High Court in the Writ Appeals.
 - No. of pensioners of the Exempted Establishments above mentioned in the State of Kerala who have been granted revised pension after the dismissal of SLPs up to October 2017 in the EPFO Branches at Palakkad, Kollam, Kozhikode, Kottayam, Trivandrum or any other EPFO Office in the State of Kerala (Month wise and Branch wise statement).

- 5. Please confirm as to whether the figures furnished for serial no.4 above are pertaining to the EPS 1995 pensioners who had paid already 8.33% of Employer's Contribution for the statutory ceiling amount of Rs.5000/- and Rs.6500/- into Pension Fund account maintained by the EPFO Office and the balance of 3.67% of Employer's Contribution amount was maintained in the Trust accounts till the date of their Superannuation and now paid the difference of Employer's Contribution of 8.33% on the higher salary with up to date interest directly by the pensioners, after the receipt of communications from the Branch Offices of EPFO in to the Pension Fund account maintained by EPFO Office and balance of 3.67% of the Employer's Contribution retained with the pensioners in the State of Kerala, after their Superannuation.
- 6 Certified copies of references (letters)received from the various Field Offices of EPFO by the EPFO Head Office at New Delhi after the issue of EPFO Head Office circular No.pension-I/12/33/EPS Amendment/96/Vol .II dated 23.3.2017.
- Certified copy of the circular issued by EPFO Head Office to all its Field Offices or any Inspecting authority(viz. Actuary) nominated by EPFO advising them to verify the Books of Records of the Exempted Establishments and the EPF Trusts and to submit their reports to EPFO at New Delhi, as per the recommendations of the 38th PEIC and 215th CBT and as per the approval of the MOL &E dated 16.3.2017.
- 8: Certified copy of the inspection report submitted by the Inspection authority (Actuary)or by the Office of the concerned RPFC, Dwaraka, New Delhi after verification of Book of Records of the Exempted Establishment and the Trust viz.
