- a) Your Circular No. Pension-1/12/33/EPS Amendment/96 vol.II dated 31st May 2017 SI.No.v states as follows: "In the case of exempted establishment the provident fund and pension fund are managed by separate legal entities. The provident funds of the employees of exempted establishment are managed by the Exempted Trust and Pension fund is managed by EPFO. As such, adjustment of contribution from Provident Fund Account to Pension Account as contemplated in the Judgment is not possible"

In the above lines of your said Circular dated 31.05.2017 it is elucidated that employees of exempted establishment are not

entitled for pension on full salary. It is given to understand that the Airport Authority of India, which is an exempted establishment and the PF managed by the trust over there, is already availing the benefits before the pronouncement of Supreme Court judgment and for years together.

You may kindly inform how many such exempted establishment, like Airport Authority of India (AAI), where PF is managed by the Trust, are getting the benefits of pension on full salary earlier to the judgment of Supreme Court and still continuing.

b) You are requested to kindly inform, under which rules/provisions of the Act has been invoked to deny the exempted Trust disbursing with the pension on full salary as stipulated at the Sl.No.v of your Circular cited above at (a)

- 4.
