#### **Indian Safety Song and Video Contest 2019**

#### Terms of Participation

The Indian Safety Song and Video Contest (SSVC) is part of the International Vision Zero Conference in Mumbai. The organisers of the SSVC are the German Social Accident Insurance (DGUV), the Electricity and Construction sections of the International Social Security Association (ISSA) and the Indo-German Focal Point (hereinafter referred to simply as "Organisers").

#### Participation:

Parties interested in participating in the contest can do so by sending in their media contributions. Such contributions can consist of films, music videos and songs applications (hereinafter referred to simply as "contribution"). Parties invited to participate in the SSVC include <u>in particular</u>: institutions involved in the work field of "Safety and Health at Work", companies, agencies, film producers, multimedia companies and television broadcaster (hereinafter referred to as "Participants").

#### **Participant Contributions:**

To be eligible, contributions must address the topics of safety and/or health in the workplace. The contributions should pursue at least one of the following objectives:

- motivation or instructions for safe behaviour.
- focusing attention on or creating awareness for recognising hazards in the workplace
- improving company organisation/communication

Contributions which fail to fulfil these criteria or which feature advertising, offensive or radical content can be rejected. The decision regarding such rejections will be made by the organisers or jury members. As such, no legal recourse is possible regarding such rejections.

#### **Entry Deadline:**

The deadline for entries is August 31<sup>st</sup>, 2018. Contributions received after this date can no longer be considered for participation. However, the Organisers reserve the right to move the entry deadline to a later date.

#### Registration:

A Registration Form must be filled out for each contribution submitted. This form can be downloaded at <a href="www.indogermanfocalpoint.com">www.indogermanfocalpoint.com</a> or you can you can request a form by writing an email to ssvc2019@gmail.com.

#### Format and Medium:

Contributions can be submitted using We Transfer (www.wetransfer.com).

The Participants are responsible for the technical quality of the contributions. The Organisers accept no liability whatsoever for any loss of quality resulting from the transmission of the contributions.

The Organisers will not charge the Participants for the participation in and of itself or for any processing of the contributions.

#### Languages:

Contributions will be accepted in English and Hindi and their registration must be written in one of these languages.

#### Jury

An independent jury comprised of experts from the fields of communication and prevention will evaluate all of the approved contributions and will ultimately select the prize winners by majority vote.

#### Social Media

The winner productions will be included on the website or YouTube channel of the Indo-German Focal Point, if the participants have given the rights to do so.

#### **Award Ceremony/Prizes**

In autumn 2018, the jury will decide which contributions are to be nominated for a prize. The Participants will be notified of these decisions. The winners of the SSVC will be announced and will be awarded their prizes during the International Vision Zero Conference in Mumbai.

#### Prizes are as follow:

1<sup>st</sup> place: 56.000 INR 2<sup>nd</sup> place: 40.000 INR 3<sup>rd</sup> place: 24.000INR

Furthermore, each winner can send one representative to the award ceremony at the International Vision Zero Conference with flight and accommodation costs included.

If an award winning Participant is unable to attend the award ceremony, the monetary

prize will be transferred to the respective Participant's account.

#### **Rights and Obligations**

The Organisers of the SSVC are authorised to use and publish the personal data of the prize winners for public relations work within the framework of the contest. Such data includes the name of the Participant and/or his/her title, function and/or professional field of activity and more specific details regarding the submitted contribution.
