Sir,

Office Circular HRM-Please refer to the Head No. IV/60(1)2013/SSA/Pt./15378 dated 05.11.2015 vide which the admissibility of benefits under MACP Scheme 2009 had been clarified in order to avoid any irregularity in grant of MACP cases where three promotions / financial upgradation to Social Security Assistants had already been allowed. As per para 5 of above letter, it was stated that there are cases of MACP which do not fall under the category mentioned at Para 3&4 which may be examined on the basis of facts of each case and the provisions/illustrations under MACP Scheme and may be referred to this office in case of any doubt.

eligible officials in the cadre of Social Security Assistant - regarding.

- 2. Some references have been received from RO, Kandivili and other field offices for grant of financial up-gradation under the MACP Scheme in respect of eligible officials in the cadre of Social Security Assistant. There may be cases where only two promotions/up-gradations have been granted to the Social Security Assistant i.e. promotion from Lower Division Clerk to Upper Division Clerk i.e. from pay scale of Rs. 3050-4590 (as per 5th CPC) to pay scale of Rs. 4000-5000 (as per 5th CPC) and thereafter they were granted the scale of UDC (SG) after completion of 17 years in the pay scale of Rs. 5000-8000 (as per 5th CPC) as per prevailing instructions before 2004. Further, they have not been granted any benefits under the existing scheme for up-gradation of SSAs after 01.04.2004. In such cases, they can be allowed 3rd financial up-gradation under MACP Scheme, 2009.
- 3. It is therefore, directed to take necessary action in such cases for providing the benefits of financial up-gradation under MACP Scheme.
