Requirements of Officers also vary from location to location and it may be desirable to identify more than one make or model.
- The Committee may refer to the decision of the EC taken in its 80th Meeting held on 18.12.2014 and connected documents and files including the latest circulars/ instructions issued by

the Government of India, Ministry of Finance. The Committee may also take the input from any of the Field Offices with regard to availability of the Models and their utility within Net Dealer Price (NDP) as fixed for vehicles available in the DGS&D rate/GeM.

- 4. The team of the Officers at Headquarters will prepare the base documents and thereafter the same will be referred to the team of Officers in the Field Offices who will further deliberate on the issue and extended discussion can take place on Video Conferencing.
- 5. The Committee is requested to complete its exercise at the earliest as possible and the final recommendations be forwarded to Headquarters by 30.08.2018 positively.
