Dear Sir,

This letter has reference to letter no. Adm.I/CATCASE/DL(N)/2014/Misc/502 dated 27-04-2018 sent by Delhi (North) on the above mentioned subject matter (Copy enclosed). It has been informed by Delhi North office that consequent upon the re-distribution of pin codes amongst the five Regional Offices of Delhi Region, most of the cases pertaining to the High Court of Delhi, NCDRC, AAIFR and BIFR, fall within the geographical jurisdiction of Delhi (Central) and hence in the interest of ease of work and efficiency, Delhi (Central) should be nominated as nodal office for representing all the cases pertaining to other regional offices of EPFO concerning the Courts in Delhi.


Please refer to this office letter of even no. dated 17.01.2018 on the subject cited above wherein it was informed that RO, Delhi (North) is functioning as the nodal office for processing the legal cases pertaining to other Regional Offices of EPFO and accordingly, this office is representing the cases of other regions in various Courts/Forum apart from the cases which pertain to RO, Delhi (North) itself.

2. It was further informed that consequent upon the re-distribution of pin codes amongst the five Regional Offices of Delhi Region, it is observed that most of the cases pertain to the High Court of Delhi, NCDRC, AAIFR and BIFR, which fall within the geographical jurisdiction of Delhi (Central).

3. Hence, the Head Office was requested to accord approval for nominating Delhi (Central) office as the nodal office for representing all the cases pertaining to other regions which are filed before the above Courts/Forum. However, the requisite decision in the matter is still awaited.

4. In view of the above, it is again requested to accord approval for nominating Delhi (Central) office as the nodal office for representing all the cases pertaining to other regions concerning the above mentioned Courts in Delhi.

In this connection, it is stated that at present RO, Delhi North (Delhi -1) has been functioning as the nodal office for processing the legal cases pertaining to other Regional Offices of EPFO. Therefore, at present, RO, Delhi North (Delhi -1), represents the cases of other regions concerning the above Courts apart from the cases pertaining to RO. Delhi North itself.

It is pertinent to note that after the pin code distributions among the reconstituted five offices in Delhi vide HO Letter No.-HRM L/D -1(2) 2017/ CR /4490 dated-01.06.2017, most of the cases, as mentioned above, pertain to the High Court of Delhi, NCDRC, AAIFR and BIFR, which fall within the geographical jurisdiction of Delhi Central (Delhi-5 Office). The Courts which do not fall under the geographical jurisdiction of Delhi Central Office are the District Courts and District Consumer Forums where pendency of cases pertaining to other offices outside Delhi is almost negligible.

In view of the foregoing, approval may be granted for nominating Delhi Central Office (Delhi-5 Office) as the nodal office for representing all the cases pertaining to other regions concerning the above-mentioned Courts in Delhi. Alternatively, in the interest of ease of work and efficiency, the respective five Regional Offices in Delhi may be nominated as the nodal offices for handling cases pertaining to other regions according to the geographical jurisdictions of the corresponding courts. Decision by the Competent Authority in the matter may be communicated to this office so that the matters pertaining to other regions may be transferred to Delhi Central Office.
