In this context please refer the order of the full bench of CIC in Appeal No. CIC/AT/A/2008/01280, dated 29.09.2008 between Sri Ketan Kantilal Modi Vs. Central Board of Excise & Customs wherein it is held as under:-

"In case CPIO, CBEC transfers appellant's RTI application electronically to the subordinate Commissionerates, the latter shall process these information requests as independent requests under Section 6(1) and collect from the petitioner all requisite fees including the application fee as if the application were made independently by him to that public authority subordinate to the CBEC."

ORDER IN APPEAL UNDER RTI ACT, 2005

1 2 JUL 2018

An appeal under section 19(1) of the RTI Act, 2005 filed by Shri Varinder Kumar Gupta vide letter dated 11.06.2018 against the information furnished by the CPIO/RPFC-I (Exemption). Applicant has mentioned that the information furnished by the CPIO (Exemption) vide letter letter No. Exem./10(56) 2018 / RTI /1571 dated 21.05.2018 in response to the RTI application dated 11.05.2018 is not satisfactory.

- 2.. The appeal filed by the appellant has been considered by the undersigned and is pleased to pass the following order –
- The information sought under point no (1) of the applicant's RTI application dated 11.05.2018, is freely available on the official website of EPFO under the Tab, ""Status of Establishments". As far as the signed/attested copies of the information is concerned, the order of the Information Commission in the matter of K. Lall vs M. K. Bagri and the order of the CIC dated 02.05.2016, in the matter of Smt. Nirmal Garg, Delhi may be referred to, where the Commission has clearly laid down that the information which is freely available or is available on payment of predetermined price from any public domain cannot be considered as an accessible information under RTI Act, 2005 since it is not exclusively held or controlled by a public authority and hence cannot be furnished under the RTI Act, 2005.
- ii) Further the information sought under point no.(2) of the RTI application dated 11.05.201, regarding the list of exempted establishments under EPF Scheme,1995 but not under EPS,1995 wherein EPS, 1995 member are getting pension on actual or full salary is not available with the EPF exemption section. However, the CPIO (Exemption) is directed to forward this point to CPIO(Pension) for providing the available information, if any, to the applicant directly.
- The appeal is disposed off accordingly.
- 4. Further, appeal under the RTI Act, 2005 lies with the Hon'ble Central Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067.




