Department of Personnel & Training vide its O.M.s No.29062/6/2015-AIS(1)-(S) dated 30.09.2015, No.29062/06/2015-AIS(I)-Part(IV) dated 12.03.2018 & No.29062/06/2015-AIS(I)-Part(III) dated 16.04.2018 has prescribed certain measures in exercise to review existing mechanism to ensure probity among government servants. In this connection they have devised certain formats of reports to be uploaded/entered into on the probity portal. The Ministry of Labour & Employment vide OM No.C-31015/1/2017-Vig dated 27.06.2018 directed the EPFO to upload data by 10th day of every month on the Probity Portal and send hard copy to the Ministry for compilation by 12th day of every month. This work has now been assigned to Administrative Vigilance Section (AVS), Head Office.
