In a global context characterized by complex and pressing challenges, the social and solidarity economy (SSE) is receiving growing attention for its role and potential to address social and economic issues faced by individuals and communities. SSE is well positioned to address the emerging challenges related to the world of work as outlined in the [ILO Centenary Declaration for the Future of Work](#).

2. The ILO is organising a webinar on "SSE momentum: Finance for Inclusion and the Future of Work during Covid-19 pandemic". The speakers will reflect on the key challenges related to the future of work, how they affect local communities, and what SSE institutions are doing or could do toward addressing them.
