Further, since contact details of offices under PDNASS, Vigilance Wing, Internal Audit Wing, National Data Centre and Head Office are also shown on EPFO's website, Director, PDNASS, and divisional heads of Vigilance, Audit, NDC and ASD are also requested to take similar action.
