2. In this regard, it is informed that it has been decided by the Competent Authority to conduct the above-mentioned **Probationary Exam for the Enforcement Officers/Account Officers (DR) from 22.08.2022 to 26.08.2022** at Zonal Training Institutes as per the enclosed list.

3. The above-mentioned probationary exam will be conducted in offline mode. The following instructions are issued for strict compliance by all concerned offices:

- i) Exam Centers: The exam will be conducted at Zonal Training Institutes as per the list enclosed herewith. The concerned Zonal Training Institutes are requested to ensure that the exam is conducted in fair and objective manner. It should also be ensured that no unfair means are used by the candidate's reference.
- (ii) List of candidates: A ZTI-wise list of candidates (Enforcement Officers/Account Officers (DR) alongwith their respective Roll No. is attached herewith for information and further necessary action. All ZOs/ROs are requested to check the said list carefully to ensure that no eligible candidate is left out of the above list. If it is found that there is any other EO/AO (DR) left out of the above list, same may please be brought to the notice of PDNASS as well as Zonal Training Institute immediately alongwith the copy of the appointment letter for further necessary action.
- (iii) Admit Cards: All the concerned controlling officers/Officers-In-Charge are requested to issue Admit Cards (as per the prescribed format attached herewith) to the eligible candidates and also to send a copy of the same through email to the concerned Zonal Training Institutes where the EOs/AOs are required to appear for the aforesaid probationary exam. The concerned Zonal Training Institutes are also requested to follow up with the concerned ZOs/ROs for doing the needful.
- (iv) Board of Examination: As per extant instructions all exam centres are required to constitute a Board of Exam to conduct the exam in fair and objective manner as per the EPF, Hqrs instructions on the subject. Hence, all concerned Addl. CPFCs/Regional Provident Fund Commissioners-I are requested to constitute Board of Exam as per the instructions issued by EPF, Hqrs. The Board of Examination shall consist of one RPFC-I as Supervisor, one RPFC-II/APFC as Assistant Supervisor and one independent member (preferably Group 'A') as Member-cum-Invigilator either from ESIC or any other Central Government Office situated in same city/location. The information of constituting the Board of Exam and specimen of internal and external seal of the office to be fixed on the sealed cover of Answer sheets and Forms 'A' to 'J' as per Hqrs instructions may please be sent to PDNASS at the earliest. The mobile numbers and official email addresses of the Supervisor of the Board of Exam may also please be provided.
- (v) Examination Hall and other facilities: The monitoring of the above exam will be done by PDNASS through online mode. Hence, the above exam is required to be conducted in a conference/meeting hall having sufficient sitting capacity with social distancing for examinees and fully equipped with high speed internet connection, webcam and power back-up. The conference/meeting hall should also be equipped with CCTV facility (with recording facility). The concerned ZTIs are required to ensure video recording of the exam on all five days and send the said video recording to PDNASS in a pen drive.
- (vi) Central Observer: PDNASS will nominate an officer as Central Observer from any of the nearby EPF offices for the above exam. The Central Observer shall submit a report to the Director, PDNASS regarding the conduct of the exam as per instructions issued in this behalf (A copy of the same is enclosed herewith).

Further instructions regarding blank Answer Sheets, Continuation Sheets, Question paper, evaluation etc. will be issue to concerned ZTIs separately. All concerned EOs/AOs (DR) may also be informed accordingly.
