- iii. The Campaign shall also be implemented in all outstation offices of Ministries/ Departments and autonomous organizations/subordinate offices/attached offices.
- iv. Secretaries are to monitor progress on monthly basis. Nodal officers to monitor progress on weekly basis and enter data on DARPG portal on monthly basis on the 1st of every month.
