Subject:- Grant of MACP to EO/AO, APFC and RPFC-II who have joined through DR 1999 Batch-reg.

Sir/Madam,

Kind reference is invited to the subject cited above and to say that most of the officials who joined through Direct Recruitment 1999 batch have got the benefit of MACP, however some of the officials are still left who have not got the benefit of MACP. Hence, to provide the MACP to the leftover EO/AO, APFC and RPFC-II, it is requested to provide the information/document in the below given format:-

2. Zonal Offices are requested that if the proposal has already been sent without VCC (received from Vigilance and DAR Section), then the same proposal may be sent again after obtaining VCC through VCIT Portal.

3. Further, it is also informed that as per the clarification dated 07.03.2016 (copy enclosed) received from Ministry of Labour & Employment whereby Ministry has informed that *MACPS required to be proceed in advance, which inter-alia implies that the Vigilance clearance is to be seen on the eligibility date of the concerned employee. In case the employee is fallen under any of the three conditions as laid down in the DoPT OM dated 14.09.1992, the procedure of sealed cover require to be followed.* Zonal Offices are requested to send the proposals again, as per the above clarification, w.r.t the officials whose MACP has been denied due to VCC as on current date being not clear, but as on date of eligibility is clear.

Sub: Clarification on grant of MACP to Smt. Anita Pandey, APFC. - reg
Sir,

I am directed to refer to your office letter no. HRM-III/18(03)2012-
MACP/EO-AO/DL-UK Regions/3636 dated 21.01.2016 on the subject
mentioned above and to say that on examination, it has been observed
that Smt. Anita Pandey, APFC was free from vigilance angle on 1.9.2008.
As per para 6 of the DoPT's OM dated 19.05.2009, the proposal relating
to grant of financial up-gradation under MACPS required to be proceed
in advance, which inter-alia implies that the Vigilance clearance is to be
seen on the eligibility date of concerned employees. Hence, Smt. Anita
Pandey, APFC should have been granted financial up-gradation under
MACPS w.e.f. from eligibility date i.e. 1.9.2008

2. In case the case of Ms. Anita Pandey, APFC is fallen under any of
the three conditions as laid down in the DoPT's O.M dated 14.9.1992, the
procedure of sealed cover required to be followed.

3. EPFO is therefore requested to take necessary action accordingly.
