In terms of Section 15 of the Social Security Code 2020( "the Code"), the Central Government, by notification, has to frame the following three Schemes:-

- (i) Employees' Provident Fund Scheme (EPFS)
- (ii) Employees' Pension Scheme (EPS)
- (iii) Employees' Deposit Linked Insurance Scheme (EDLIS)

2. The draft of the above three Schemes are, therefore, to be prepared and placed before the Government of India (MoL&E), for consideration. Accordingly, the following Committees are constituted for framing of the draft Schemes:-
