The number of SSAs who come under 60:40 rule are being maintained at respective Zonal Office being the cadre controlling authority. Therefore, the application is being transferred to all CPIO, Regional Offices under section 6(3) of RTI Act, 2005 to provide the information directly to the applicant.
