Sir/Ma'am,

Please find attached herewith the RTI Application of Sh. Akhil S Nair received in Recruitment Division under the RTI Act, 2005.

2. On scrutiny of the application, it is observed that, information sought at Point no. 1 & 3 pertains to HRD Division, Point no. 2 pertains to all the Zonal Offices and point 4 pertains to Zonal Office (Kerala & Lakshdweep), HRM & HRD Division. Further, details of the application are as under-

S.N.	Information Sought	Concerned CPIO/CPIOs
1	In all India level, how many vacancies are reserved for compassionate ground?	The matter is related to policy for compassionate appointment. The same pertains to HRD Division, Head Office. Accordingly, HRD Division is requested to provide the information directly to the applicant.
2	In all India level, how many candidates were appointed on compassionate ground between 01/01/2023 to 31/07/2024. Especially in Kerala region and also which department?	The matter pertains to all the Zonal Offices. Accordingly, it is requested to provide the respective information directly to the applicant.
3	What is the current status of the draft guidelines that say 35 marks are enough for Compassionate Appointment?	The matter is related to policy for compassionate appointment. The same pertains to HRD Division, Head Office. Accordingly, HRD Division is requested to provide the information directly to the applicant.
4	How many compassionate appointment vacancies are there in Kerala region?	The matter pertains to Zonal Office (Kerala & Lakshdweep), HRM & HRD Division. Accordingly, it is requested to provide the information directly to the applicant.

- 3. Therefore, in accordance with section 6(3) of the RTI Act, 2005 the application is hereby transferred to concerned CPIOs as detailed at Para 2 above for supply of the information directly to the applicant.
- 4. It may be mentioned that if the desired information does not pertain to the concerned division/Public Authority or some part of information is held by other division / public authority or some part of information is held by other division/public authority the concerned CPIO shall forward/transfer the application or such part of it as may be appropriate to relevant division/public authorities u/s 6(3) of the RTI Act, 2005 and inform the applicant immediately about such transfer. However, if the CPIO is not able to find out as to which division/public authority is concerned with the information even after making reasonable efforts to find out the concerned division/public authority to which the application could be transferred. It would, however be the responsibility of the CPIO, if an appeal is made against his decision, to establish that he made reasonable efforts to find out the particulars of the concerned division/ public authority.
- 5. The Name & Address of the Appellate Authority may also be mentioned in the reply, so that the applicant can make an appeal within 30 days from the expiry of such period or from the receipt of decision given by the public authority if he is aggrieved by the decision.
