**Subject: Creation of Supernumerary posts in the cadre of Enforcement Officer/Accounts Officer (EO/AO), Section Supervisor (SS) & Lower Division Clerk (LDC) for Persons with Benchmark Disabilities (PwBD) officials in compliance with DoPT O.M. dated 28.12.2023-reg**

Madam/Sir,


The Central Board of Trustees (EPF) (CBT), in its 238th meeting held on October 13, 2025, deliberated upon the Agenda Item for creation of supernumerary posts in the cadre of Enforcement Officer/Accounts Officer (EO/AO), Section Supervisor (SS) & Lower Division Clerk (LDC) for Persons with Benchmark Disabilities (PwBD) officials in compliance with DoPT O.M. dated 28.12.2023.

2. The Department of Personnel and Training (DoPT) issued O.M. dated December 28, 2023, providing guidelines for granting reservation benefits in promotion to PwBD officials, including notional promotion effective from June 30, 2016, subject to fulfilling eligibility conditions.
3. To avoid administrative inconvenience resulting from potential inter-se-seniority revisions across various grades and subsequent chain effects on revised seniority lists, the DoPT guidelines mandated the creation of supernumerary posts. These supernumerary posts are created for a fixed period to adjust the lien of PwBD employees who receive the benefit of reservation in promotion on a notional basis.
4. The posts created are supernumerary and personal to the respective PwBD employee. Such a post shall stand abolished on the date the PwBD employee is adjusted against an available vacancy in that grade, or when the employee vacates the post due to retirement or further promotion, whichever is earlier. The notional promotion benefit includes promotions via the Seniority Quota (SQ) and the Examination/Departmental Competitive Examination Quota (EQ).
5. The CBT approved the proposal for the creation of these supernumerary posts in the cadres of EO/AO, SS, and LDC. The specific details of the supernumerary posts created, including the name of the official, the state, the cadre, the quota (SQ or EQ), and the time duration for which the post is created, are enclosed herewith as Annexure 'A'. The order for creation of supernumerary posts for SS (EQ) and therein officials who are eligible for second

promotion in EO/AO (SQ) will be issued separately on the basis of the order of Hon'ble Supreme Court in SLP.

6. Accordingly, all Zonal Offices are requested to conduct DPC for promotion of the officials mentioned in Annexure A and forward the proposal to Head Office for EO/AO Cadre and also initiate necessary action for SS and LDC cadre at their end, duly following the DOPT circular dated 17.05.2022 and 28.12.2023. Also, complete due diligence is to be carried out by the DPC including the verification of the disability certificates submitted by the concerned employees from the concerned Competent Authority, as per directions issued vide EPFO letter dated 16.07.2025 (Copy Enclosed). Further, verification of the names of the officers/officials, their eligibility as per DoPT guidelines, and the duration for which the posts are created vis-à-vis the names of the respective officials may be ensured.

**Subject: Creation of Supernumerary post for providing notional promotion to PwBD officials in the cadre of EO/AO, Section Supervisor & LDC- regarding.**

Sir/Madam,

With reference to subject cited above, it is informed that as per para 2.3 of the DoPT OM dated 17.05.2022, "The authenticity of any certificate, issued by the competent medical authority, may be got verified/re-verified by the appointing authority at the time of appointment."

2. In this connection, reference is invited to FAQ (copy enclosed) issued by DoPT in this regard, as per the said FAQ, following are the guidelines for disability certificate: -

*The competent authority to issue Disability Certificate shall be a Medical Board duly constituted by the Central or a State Government. The Central / State Government may constitute Medical Board(s) consisting of at least three members out of which at least one shall be a specialist in the particular field for assessing locomotor / cerebral/ visual / hearing disability, as the case may be.*

*The Medical Board shall, after due examination, give a permanent disability certificate in cases of such permanent disabilities where there are no chances of variation in the degree of disability. The Medical Board shall indicate the period of validity of the certificate, in cases where there are chances of variation in the degree of disability. No refusal of disability certificate shall be made unless an opportunity is given to the applicant of being heard. On representation by the applicant, the Medical Board may review its decision having regard to all the facts and circumstances of the case and pass such orders in the matter as it thinks fit.*

3. All the Zonal Offices are requested to verify from the Competent Authority which has issued the disability certificate of the officials (list enclosed) are genuine and has been issued duly following the guidelines mentioned in para 2 above.

4. A compliance report of the direction mentioned in para 3 be submitted within 15 days from the issue of this letter.
