

Reference: Circular No. 33/7/2023-24/SSAS(DR)Prob.Exam-2021/604 dated November 28, 2025, regarding the SSA Probationary Examination

Following the referenced circular, all ACC (HQ)s and Zonal ACCs were requested to review and report any discrepancies in candidate data (Annexure I & Annexure II) by December 05, 2025.

This office has received emails from various Zonal/Regional Offices highlighting discrepancies in the data of candidates as initially uploaded in Annexure-I & Annexure II. The information received from the field Offices regarding these candidates has been duly taken into consideration. A revised Annexure-I & Annexure II, incorporating these updates and corrections, is uploaded and enclosed with this circular.

To ensure the smooth and efficient conduct of the upcoming examination, the following instructions and updates are hereby issued:

- 1. Due to significant changes in the place of posting, candidates listed in the Revised Annexure-I have been assigned new roll numbers and their respective Examination Venues. Candidates reappearing for the Probationary Examination (listed in Annexure II) will retain their original roll numbers.
- 2. After finalizing all eligible candidates for the upcoming SSA Probationary Examination, all concerned Zonal ACC (HQ)s/ ACCs & Nodal Officers are requested to make necessary arrangements for the conduct of the examination at the respective centres/venues in accordance with revised number of candidates at their Examination centre/venue.
- 3.All Zonal ACC (HQ)s/All Zonal ACCs, ACCs/RPFC-Is, PDUNASS Campuses, and all RPFCs/OICs of Regional Offices/District Offices are requested to take note of these updates and ensure compliance with all instructions issued vide detailed Notification dated 28.11.2025 for the successful conduct of the Probationary Examination.
- 4. All the nodal officers nominated by the concerned Zonal ACC (HQ)s/ ACCs / ACCs PDUNASS Campuses are requested to communicate their official email address to the Controller of Examination on coe.PDUNASS@epfindia.gov.in.

- 6. All nodal officers and the concerned field offices are requested to co-ordinate among themselves to ensure that scanned copies of Admit Card (with updated Roll number and Venues) shall be mailed to the nodal officer well before the scheduled date of Examination. All ACCs HQ/ ACCs of the offices conducting the examination are requested to communicate the details of the nominated Nodal Officers for their respective Examination Venue/centre to the respective field offices where candidates are posted.
- 7. Any further communication pertaining to this Probationary Examination should be directed to the Controller of Examination via email at coe.PDUNASS@epfindia.gov.in.
