Sir/Madam,

The list of 696 candidates selected from the 2<sup>nd</sup> Waiting List for the Social Security Assistant (SSA) Direct Recruitment Examination was circulated vide the above-referred order dated 26.09.2025. The process for formal appointment of the candidates in the list is to be commenced. All candidates in the list are requested to carefully go-through the contents of this letter and complete the appointment formalities as per the instructions given below.

- 2. The candidature of candidates is purely provisional and subject to verification of documents, Medical examination and other eligibility criteria. The final merit list shall be prepared Region-wise which shall be used for the preparation of the seniority list etc.
- 3. The following instructions for each stage are brought to the attention of all the candidates so that the process of appointment can be completed in a smooth and time-bound manner.

#### STAGE I: State/Regional Office Allocation

The allocation of State/Region to the selected candidates has been intimated vide the above-referred order dated 26.09.2025. The allocation of State/Region is done by applying the principle of Merit-cum-Preference purely based on preferences

submitted by the candidates during the filling of the online application form, subject to availability of vacancies and extant rules. The Zonal Office will further allocate the Regional Office under its jurisdiction to the candidates on the basis of the guidelines issued by the Head Office vide Order No. Recruitment/Exam.12(1)2025/SSA/388 dated 03.01.2025.

# STAGE II- Pre-appointment formalities of verification of original documents and submission of requisite forms.

- (a) Based upon the allocation of states to the selected candidates, the list of the candidates along with the soft copy of dossiers are being sent to the concerned Zonal Offices, where the candidates are required to appear for verification of identity, documents and to fill and submit Annexures (at serial number vii, viii, ix & x below and undertakings). The date and venue in this regard will be intimated by the concerned Zonal Office to the candidates. The candidates will be required to report to the respective Zonal Office on the appointed date along with original documents in support of educational qualifications, age, caste, etc. The list of original documents that are required to be produced by the candidates during verification is as follows:
  - Original Certificates of Educational Qualifications along with a set of self-attested copies.
  - ii. Original Certificate of Age along with self-attested copy.
  - iii. Original Relieving order from the present employer, if any, is required to be produced by the candidates at the time of joining the post of Social Security Assistant. However, No Objection Certificate (NOC) issued by the present employer is required to be produced by the candidate during verification of documents.
  - Original Caste Certificate in the case of SC/ST/OBC/EWS along with self- attested copy.
  - v. EWS Candidates are required to produce original Income and Asset certificate from the prescribed authority valid for the year 2022-23 along with self-attested copy.
  - vi. PwBD candidates are required to produce the original Disability Certificate issued by the prescribed Medical Authority in accordance with the instructions issued by the Department of Empowerment of Persons with Disabilities, Ministry of Social Justice and Empowerment, Government of India, along with a self-attested copy.
  - vii. Original Form on Oath of allegiance to the Indian Constitution. (Annexure-I, format enclosed)
  - viii. Original Form on Declaration of Marital Status in the form enclosed. (Annexure-II, format enclosed)

- ix. Application seeking exemption in terms of Rule 21 of CCS(Conduct) Rules, 1964 (**Annexure-III**, format enclosed), if applicable.
- x. Attestation Form (**Annexure IV** format enclosed)
- xi. Original Aadhar Card and PAN Card along with self- attested copy.
- xii. One recent passport-size photograph
- (b) The Zonal Office on receipt of dossiers from the Head Office, will issue communication to the selected candidates through e-mail/ speed post/ SMS/phone call to appear on a pre-appointed date for identity and document verification. It may be planned in such a way that the verification and medical examination are carried out smoothly.
- (c) During the verification of the above mentioned documents, the Zonal Offices will also obtain the below listed undertakings:
  - i. The candidates belonging to OBC community will be required to furnish an undertaking that they do not belong to Creamy Layer as on the closing date of submission of application for the post i.e. on 26.04.2023 [Undertaking to be submitted by the candidates (Undertaking Format enclosed as **Annexure-V**)].
  - ii. The candidates belonging to EWS, will be required to furnish an undertaking that they had EWS status for the financial year 2022-23. [Undertaking to be submitted by the candidates (Undertaking Format enclosed as **Annexure-VI**)].
  - iii. Ex-servicemen candidates are required to submit an undertaking stating that they have not availed the benefit of reservation for exservicemen in reemployment to any civilian post.
  - iv. Candidates already in government service who have claimed age relaxation in accordance with para 4.2(III) of the NTA advertisement No. A-12024/3/2021-EXAM/188 are required to submit the declaration in **Annexure VIII**.

### STAGE III- Issuance of Offer of Appointment & submission of Acceptance

After the verification of the original documents, the Zonal Offices will issue the Letters of Offer of Appointment (format enclosed at **Annexure IX**) to the candidate on the same day and receive acknowledgement for the same. The candidate will be required to submit his/her letter of acceptance in **Annexure X** to the offer of appointment latest within 7 days of the receipt of the Offer of appointment. Candidate, however, may submit his/her letter of acceptance at the time of receiving the letter of offer itself. If the candidate fails to submit the

acceptance within 7 days, the appointment shall be cancelled by the concerned Zonal Office.

#### **STAGE IV: Medical Examination**

After completion of the formalities of form filling, submission, verification of documents and identity as detailed above, the candidates will receive instructions from EPF Zonal Offices for completing medical examination formalities. The candidates must present themselves before the Medical Authorities indicated in the communication for getting themselves medically examined.

The Zonal Office will contact and make arrangements with medical authorities for referring the candidates, as per government rules for medically examining the candidates and ascertaining their fitness to be appointed on SSA Post. A sample letter for referring the candidates to the medical authority for conduct of medical examination is enclosed in **Annexure-VII**.

The candidates may then be asked to proceed for Medical Examination with the Medical Authorities for medically examining the candidates and ascertaining their fitness to be appointed on SSA Post.

NOTE: However, if the candidate is already in Government service, instead of obtaining a fresh medical report, they may produce this letter to their controlling authority to enable them to forward an attested copy of their medical examination report obtained at the time of the appointment, to the concerned Regional Office. The candidates must ensure that the said medical examination report furnished by the previous employer should have been issued by Civil Surgeon/Chief Medical Officer or equivalent.

(\* This condition is optional for the candidates already in Government service. If the candidate wants, he/she can appear before CMO as directed by concerned Zonal Offices and get the medical examination done afresh.)

### STAGE -V: Issue of Provisional / Final Letters of Appointment

On receipt of their Medical Fitness Certificate, the acceptance of the Offer of Appointment and other requisite documents, the Provisional Letters (format enclosed as **Annexure -XI**) will be issued through Rozgar Mela 2025, the details and venues of which will be intimated to the candidates by the concerned Zonal Office.

- 4. While verifying the Character and Antecedents of the Ex-Servicemen and other selected candidates, Zonal Offices must follow the instruction issued vide Head Office Circular No. A-12011/12/2024-EPFO-HQ/RC/328 dated 07.11.2024.
- 5. The Final Appointment orders will be issued by the Regional P.F. Commissioner-I in charge of Human Resources at Zonal Office on receipt of Verification of Character and Antecedent certificates from concerned District /Police Authorities as well as Caste, EWS, PwBD certificates from the concerned issuing authorities in due course.
- 6. All the candidates are advised to take note of the above instructions and see to it that they complete the actions as indicated. They will be informed of further instructions by means of email on their email IDs.

#### **OFFER OF APPOINTMENT**

Subject: Offer of appointment to the post of Social Security Assistant in the Employees' Provident Fund Organization, Ministry of Labour and Employment in Level - 5 in the Pay Matrix as per 7th CPC (Rs.29,200-92,300), Pre-revised PB-2 Rs.5200-20200 (with Grade Pay of Rs.2800/-) Non-gazetted Group 'C', Non-Ministerial.

- 2. The appointment to the said post is subject to following terms & conditions:-
  - I. This post carries a Level 5 post in Pay Matrix. If the candidate is already in Government service, his/her pay will be fixed in the above scale in accordance with rules and conditions prevailing at the time. If the candidate is not a Government servant, he/she will be entitled to the minimum of the level in the pay matrix. Dearness and other allowances will be admissible under the rules governing the grant of such allowance in force from time to time.
  - II. The appointment of the candidate will be purely on a temporary basis until further orders.
- III. The service of the candidate will be terminable on one month's notice from either side, if post is held on temporary basis. In terms of Regulation 11 of the Employees' Provident Fund (Staff and Conditions of Service) Regulations, 2025. The notice period from either side will be of 3 months, if post is held on permanent basis. The appointing authority, however, reserves the right of terminating the services of the candidate forthwith or before the expiration of the stipulated period of notice by making payment to the candidate of a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof.
- IV. The candidate will be on probation for two years from the date of appointment. The period of probation and other conditions of service relating thereto shall be regulated in terms of Regulation 7 of the Employees' Provident Fund (Staff and Conditions of Service) Regulations, 2025. On

completion of probationary period satisfactorily which includes passing of probationary examination as per rules, the candidate will be considered for confirmation in the substantive post of Social Security Assistant. Further, failure to complete the probation period to the satisfaction of competent authority or if during the period of probation, the appointing authority is of the opinion that the candidate (Probationer) is not fit for permanent appointment to the said post of Social Security Assistant, such authority may discharge/terminate the candidate from the service, for reasons to be recorded in writing.

- V. The candidate shall be required to undergo training, e.g. Foundation /Induction Course, refresher courses, mid-term career growth, in-service skill development, retirement planning course and other mandatory courses announced by EPFO from time to time.
- VI. The leave, Travelling Allowances, Pension/NPS and all other service matters connected with service conditions will be governed by the rules and order in force from time to time that are applicable to the employees of EPFO.
- VII. The candidate is liable to be posted/ transferred anywhere in India.
- VIII. No Travelling Allowance for joining the post will be paid unless the candidate is a permanent Government Servant or has completed three years of temporary service in government.
  - IX. On joining the post, the candidate will be required to take an Oath of Allegiance to the Constitution of India and make a solemn affirmation to that effect.
  - X. The candidate who is already employed should produce a valid relieving / discharge order from the last employer.
  - XI. The candidate belonging to a category of Scheduled Caste (SC), Scheduled Tribe (ST) or Other Backward Classes-Non-Creamy Layer (OBC-NCL) or Economically Weaker Section (EWS) or belonging to the Physically Handicapped (PwBD)/ Ex Serviceman (Ex-SM) quota should produce a certificate issued in the prescribed form by anv Judicial/Revenue/Medical/Defence Authorities mentioned therein. The appointment of such candidate will be provisional and it is subject to verification of the Caste/Tribe/PwBD/EWS/Ex-SM certificate through proper channels and that if the claim to belong to SC/ST/OBC-NCL/PwBD/EWS/Ex-SM is found to be false, the services will be terminated forthwith without assigning any reason and without prejudice to such further action that may be taken under the Bharativa Nyava Sanhita, 2023 for production of false certificate. Any change of religion, after appointment should be intimated immediately to the Appointing and Administrative Authority concerned.

XII.	In accordance with the existing instructions, a person shall not be eligible for appointment under the Government of India, if he has entered into or contracted a marriage with a person having a spouse living or who having a spouse living has entered into or contracted marriage with any person, provided that the Central Government may, if satisfied that there are special reasons for doing so, exempt any person from the operation of this rule. This provisional offer of appointment is therefore, conditional upon satisfying the requirements mentioned above and also furnishing to this department a declaration to that effect in the prescribed proforma at the time of joining. If, however, you desire to be exempted from the operation of this rule for any special reason (s), you should make a representation in this behalf immediately.
XIII.	This offer of appointment is further subject to the medical certificate of fitness issued by the appropriate Medical authority for appointment to the post of Social Security Assistant. (Medical Certificate to be submitted by the candidates within 15 days of the receipt of Provisional Letter of Appointment).
XIV.	If any declaration given or information furnished by the candidate is proved false or any material information is found to have been willfully suppressed, the candidate will be liable for removal from service and other action as may be deemed necessary.
XV.	If the candidate accepts the offer on the above terms and conditions, a written acceptance/intimation may be forwarded to the undersigned immediately.
