Sir/Madam,

The Limited Departmental Competitive Examination for promotion to the post of Lower Division Clerk /Junior Secretariat Assistant under Examination Quota will be conducted through Institute of Banking Personnel Selection (IBPS).

2. The details of vacancies existing as on 31.12.2025 are given in Annexure-I of this letter.
3. The examination will be conducted as per the Examination scheme namely "Employees' Provident Fund Lower Division Clerk/Junior Secretariat Assistant Departmental Competitive Examination Scheme, 2023." The scheme of the examination was circulated vide letter dated 19.01.2024 as referred at Sl.No. 1 above.
4. The examination shall be computer based with Multiple Choice Questions (MCQs). Details of papers, time duration, subject wise marks, are given as under: -

5. The eligibility for appearing in the examination for the promotion to the post of Lower Division Clerk / Junior Secretariat Assistant shall be determined with reference to the Recruitment Rules of the said posts, which is as under:-

(i) **For LDC-** Group 'C' employee whose scale of pay is identical or lower than that of Lower Division Clerks and Group 'D' employees serving in the respective offices on the result of limited Departmental examination restricted to Group 'C' employees whose scale of pay is equivalent or lower than that of Lower Division Clerk and Group 'D' employees who possess the minimum educational qualification of matriculation or equivalent and have completed five years regular service in Group 'D' and Group 'C' isolated cadre.

(ii) **For JSA-** Group 'C' staff of Head Office who possess matriculation or equivalent pass qualification and have rendered minimum three years regular service in the grade in Level-1 in the Pay Matrix [18000-56900].

6. The cut-off date to determine the eligibility of the candidate to appear in the examination shall be 1st January, 2025 as the vacancies upto 31.12.2025 have been notified for the above examination.

7. The eligible candidates desirous of appearing in the Limited Departmental Competitive Examination for promotion to the post of Lower Division Clerk/Junior Secretariat Assistant shall fill their application form online. The tentative date of the examination is **02.05.2026**. Link for filing of the application form is given below:-

9. ACC (HQ)/ACC (Zones) / Director (PDUNASS)/ACC(ASD) are requested circulate this notice of the examination to the eligible candidates under their jurisdiction including officials posted in the ZTIs, Sub-ZTI, PDUNASS, Office of ACC (HQ)/ACC (Zones), etc.

10. Candidates shall fill their application form online within due date. The PDF of duly filled application form shall be forwarded by the candidates by 04.04.2026 to the concerned ACC (HQ)/ACC (Zones) / Director (PDUNASS)/ACC(ASD) for verification. ACC (HQ)/ACC (Zones) / Director (PDUNASS)/ACC(ASD) on receipt of the PDF of application form from candidates are requested to scrutinize the eligibility of the applicants as per the Recruitment Rules and send the details of the eligible candidates in prescribed format in Annexure II to Recruitment Division at email ID [rpfexam@epfindia.gov.in] by 06.04.2026.
