The owner shall release 50% of the estimated amount required for annual repairs and maintenance to executing agency by the start of the month for the year annual maintenance is signed. The amount spent by the Executing Agency out of this advance shall be paid on the basis of bills submitted in respect of the work done as actual expenditure received in form of expenditure statement duly audited and certified from occupant/custodian of the property certifying satisfactory completion of the work done by the agency. However, as soon as the total amount of the bills sanctioned equals the amount of advance referred above, the bills thereafter shall be adjusted for int the money lying with executing agency as advance paid in the beginning of ye'r till it is exhausted or till the end of the year, whichever is earlier
- In case of major external services, separate estimates for external service that be prepared and submitted giving full justification for the need for framing such estimates only if the owner is satisfied with the justification given by executing agency.
