

3. The promotion is subject to the following conditions:-
- (i) They are liable to be transferred out of the region on administrative grounds.
  - (ii) Their seniority in the cadre of EO/AO will be regulated as per the EPF Staff (Fixation of Seniority) Regulations, 1989 as amended from time to time.
  - (iii) On regular promotion, the officers can opt for fixation of their pay within a period of one month from the date of receipt of the orders.
  - (iv) They shall continue to be governed by the EPF (Officers and Employees' conditions of services) Regulations, 2008 as amended from time to time.
4. Accordingly order may kindly be issued after verifying the present status of their Vigilance Clearance in respect of the above officials as per the DOPT instructions.


