OFFICE ORDER

Subject:- Appointment of Shri Vikram Lal Meena, Sr. SSA, O/o Regional P.F. Commissioner-I, Regional Office, Bharuch as Auditor in Employees' Provident Fund Organization.

The Central Provident Fund Commissioner, Employees' Provident Fund Organization is pleased to approve the appointment of Shri Vikram Lal Meena, Sr. SSA, O/o Regional P.F. Commissioner-I, Regional Office, Bharuch as Auditor in the level 6 in the pay matrix (Pre-revised pay band of Rs. 9300-34800 with G.P Rs. 4200/-) in Employees' Provident Fund Organisation on deputation basis initially for a period of three years from the date of joining the post of Auditor. He is posted at - Head Office Delhi.

2. The other terms and condition of appointment as Auditor are as follows:-

- (i) The terms and conditions of deputation as laid down in the O.M. No. 2/29/91-Estt. (Pay II) dated 05.01.1994, O.M. NO. 6/8/2009-Estt. (Pay II) dated 17th June, 2010 and other instructions issued by Government of India, Ministry of Personnel, Public Grievances and Pension, Department of Personnel & Training from time to time.
- (ii) The period of deputation will be for three (03) years only unless further orders are issued before the completion of the prescribed three years for extension or for curtailment.
- (iii) He will be entitled to TA/DA and joining time as per Rules.
- (iv) On expiry of three years from the date of joining the post, the deputationist officer will be deemed to have been relieved on the date of expiry of the deputation period unless the competent authority has with requisite approvals, extend the period of deputation, in writing, prior to the date of its expiry.
- (v) In the event of the officer overstaying for any reason whatsoever, he is liable for disciplinary action and other adverse consequences which would include that the period of unauthorized overstay shall not count against service for the purpose of pension and that any increment due during the period of unauthorized overstay shall be deferred with cumulative effect, till the date on which the officer rejoins his parent cadre.

2. After getting relieved from Regional Office, Bharuch Shri Vikram Lal Meena, Sr. SSA, may report for duties to Addl. Central P.F. Commissioner, Audit Wing, EPFO, (HQ) Delhi within 15 days of issue of the appointment order.
