 - (iii) He will be entitled to TA/DA and joining time as per Rules.
 - (iv) On expiry of three years from the date of joining the post, the deputationist officer will be deemed to have been relieved on the date of expiry of the deputation period unless the competent authority has with requisite approvals, extend the period of deputation, in writing, prior to the date of its expiry.
 - (v) In the event of the officer overstaying for any reason whatsoever, he is liable for disciplinary action and other adverse consequences which would include that the period of unauthorized overstay shall not count against service for the purpose of pension and that any increment due during the period of unauthorized overstay shall be deferred with cumulative effect, till the date on which the officer rejoins his parent cadre.

 After getting relieved from Regional Office, Bharuch Shri Vikram Lal Meena, Sr. SSA, may report for duties to Addl. Central P.F. Commissioner, Audit Wing, EPFO, (HQ) Delhi within 15 days of issue of the appointment order.
