 - (v) In the event of the officer overstaying for any reason whatsoever, he is liable for disciplinary action and other adverse consequences which would include that the period of unauthorized overstay shall not count against service for the purpose of pension and that any increment due during the period of unauthorized overstay shall be deferred with cumulative effect, till the date on which the officer rejoins his parent cadre.

3. After getting relieved from Regional Office, Kandivali, Shri Dinesh, Sr. SSA may report for duties to ACC, Audit Wing EPFO, HQ, Delhi within 15 days of issue of the appointment order.
